' Annual meeting held at small farm conference

Meeting minutes as recorded by the outgoing Secretary/ Treasurer, Kelly Wendland:

The annual meeting of the Red Wattle Hog association was held November 8, 2008 at the Small Farm Trade Show in Columbia. MO. Those present included: Marjie Bender, Larry Sorell, Clyde Grover, Tommy & Theresa Thompson, Ed Seger, Donnie Bishop, Dot & Brian Jordan. Erik & Marian Van Beever, Jesse & Sally Adams, Bill Burge, George Loucks, Josh & Kelly Wendland. President Josh Wendland called the meeting to order. Those present introduced themselves for roll call.

Marjie Bender from the American Livestock Breeds Conservancy (ALBC) spoke about the role of ALBC and the importance of saving heritage breeds. The Red Wattle registration is doing well and continues to grow. She wanted to encourage breeders to: 1. understand the purpose of the hogs-they are a meat animal. 2. When breeding, cull. Select carefully and breed only the cream of the crop.

Kelly Wendland read the minutes of last years meeting. Larry Sorell moved they be approved as read. She then gave the treasurer's report with a current balance of \$885.04.

Old business:

Josh indicated we needed to vote for the vice president position. Nathan Melson was unable to attend the meeting but had indicated to Josh he would be interested in the position. Brian Jordan was nominated from the floor as a candidate as well. Clyde Grover moved nominations cease. Larry seconded the motion. A vote was taken by a show of hands and Brian Jordan won the vote. He will serve a two year term.

The group next discussed the website. Marian has been involved with getting this set up and running. Dot Jordan moved we accept the website for the association. The motion was seconded and passed. Dot moved that Marian be nominated as the website coordinator. The motion was seconded and passed. Bill & Marian will continue to work together on the site.

New Business:

The group discussed the idea of having a board of directors. After much discussion it was decided the board should consist of the three officers, and 2 members at large. The position is a one year term for the members at large. Nominations for the members were: Jesse Adams and Clyde Grover. Larry moved nominations cease. The motion was seconded and passed.

The position of secretary was voted on next. The group discussed the idea of leaving the treasurer position with Kelly or keeping it as part of the secretary's duties. Group consensus was to leave it with the secretary position. Nomination from the floor was Dot Jordan. Motion was accepted, seconded and passed.

Josh reported that ALBC was working on a pedigree registry. The group had specific questions about how this would work, what access would be available etc. Josh will get further information and get it out to the breeders. Questions/Concerns included: Is it a searchable database, can we link to our website, what is the program being considered, can we have hypothetical matings, can inbreeding be tracked.

The breed standards were next discussed. Members would like to see more specific standards be set. This will be a project for the board to work on. Are there standards or history we can get from Texas A & M on the early hogs?

The idea of voting by snail mail was discussed. Before the meeting a ballot will be sent out via snail mail and Continued on page 2

members will be asked to cast their ballot and return prior to the next annual meeting. This will allow members who can not make it to the meetings a chance to vote. Nominations from the floor could still be accepted, there should be limited voting done at the meetings, and results will be sent out by mail/website. Dot moved we implement the mail ballot and results returned to

the secretary. The motion was seconded and passed. Is there a organization newsletter? It would be a good idea to start one quarterly and post the newsletter to the website as well. The idea of conference calls was also discussed. It is an option and could be organized if there becomes a time and need for it.

The idea of a clearing house database on the website was also discussed. This would allow us to see who had pigs available for sale. The database could include a number projected to be born that would be marketable.

Breeder profiles of Red Wattle owners maybe another

good feature to add to the website. New breeders are always interested in the background of current breeders before deciding if Red Wattles are for them.

Marian moved we accept Bill as an associate member. The motion was seconded and passed.

Dot asked about letting 4-Hers submit an essay to the association for a grand prize of a 4-H hog. This was deferred to the board for further discussion.

Clyde moved to adjourn the meeting. It was seconded and passed.
